

Annual Meeting Minutes from March 23, 2024

AWSC Annual Meeting

March 23, 2024—The Osthoff Resort, Elkhart Lake, WI

DRAFT UNTIL AWSC ANNUAL MEETING – 29 MARCH 2025 – Oneida Hotel, Green Bay, WI

Meeting called to order by President Lori Heideman

Presentation of Colors by Boy Scout Troop 885 from Sheboygan Falls, singing of the National Anthem by Joe Gatzke. Pledge of Allegiance recited, veterans and military personnel recognized

Approval of the agenda - need to repair agenda under election of AWSC officers should read 2024-2025 - **motion by Brian Swan, second Dean Wandel, motion carries.**

Minutes approved from 2023 Annual Meeting, **motion by Steve Sohn, seconded Mike Fletcher. Motion Carries.**

Guest Speakers:

Introduction of Senator Devin Le Mathieu by Executive Director Mike Holden. The Senator gave a brief overview of the past session. He encourages all present to know and be in contact with their legislators.

Phil Rynish, Deputy Administrator of the Division of Fish, Wildlife and Parks

Phil explained what this department does, and how they work with planning for snowmobile trails across the state - type in Property Planning on website. Working on Blue Mounds State Park and other state parks across the state. Make sure your voice is heard.

Drew Nussbaum, Regional Tourism Specialist, WI Department of Tourism - gave an update about the winter, lack of snow, tourists still came. He discussed the Snowmobile Friendly Community program.

Proposed Bylaws Change - John Brozek & Dave Newman, Co-Chairs Environmental/Bylaws & Credentials Committee

Dave went over the by-law changes - there has been some misinformation circulating.

Article I. Corrects the fiscal year to what we're actually using, wrong month was in last revision

Club membership - yellow outline on sheet is revision. Changes who has access to database - must be a membership chair, must be a dues paying member of that club. Other club officers - President, Secretary, Treasurer must be dues paying member of that club to provide AWSC access to their contact information. These are the only 4 members that are required to be dues paying AWSC members of that club.

Club voting - cleaned up the process, we don't track what clubs are 100% AWSC members, and have no clubs under 10 members. Also clears up voting delegates, adds allowing your county Director or Rep as voting delegate - we have done it for many years, but was never in the bylaws.

Annual Meeting Minutes from March 23, 2024—Continued

Article III - Requires County Directors and Reps to be dues paying members of a club in the county they represent.

Article IV - requires AWSC officers to be dues paying members throughout their term(s).

Concerns expressed about making club officers pay dues in multiple clubs. Further concern expressed about belonging to multiple clubs, felt dues should follow the person rather than the club. We have over 3000 people that pay dues in multiple clubs. Would like clarification that the membership chair may be one of the existing officers, doesn't have to be a separate officer. Bylaws say one member has the login for the club - would like to see more than one individual per club has a special login, so you know who is making changes.

Request to break each bylaw change into a separate vote in the future.

Nominations open for Secretary - Jon Schoepke nominates Sue Smedegard. Nominations called three times. No further nominations. **Motion to close nominations and cast unanimous ballot by Cal Schmidt, second Steve Sohns. Motion carries.**

Nominations open for Treasurer - Steve Moran nominates Steve Clark. Jake Ward nominates Kate Fuchs. Nominations called three times, ballots will be counted. **Motion to close nominations by Mike Powers, Steve Moran seconds. Motion carries.**

Nominations for Vice President — Sue Smedegard nominates Randy Murdock. Ted Wampler nominates Dave Dahlke. Nominations called three times, ballots will be counted. **Motion to close nominations by Cal Schmidt, second Mike Giese. Motion carries.**

Nominations for President - Sam Landes nominates Lori Heideman. Nominations called three times. **Motion to close nominations and cast a unanimous ballot by Brian Swan, second by Joe Kniseley. Motion carries.**

AWSC Executive Officer Reports

Lori Heideman - President - changing executive board officer emails to hopefully eliminate the scams. They will become "president@awsc.org". Will be more secure and can pass along the emails along to our successors by just changing the login information.

Clubs should have received the charity and volunteer reports from ACSA - please complete these surveys, helps when we go to the US and state capitol and our other partners. Provides the information about what we do and donate.

Have been to the capitol a lot recently, get to know your legislators and politicians - local, county, state, national. Sam Landes will give the legislative report.

Annual Meeting Minutes from March 23, 2024 - Continued

Cup tour was a great event, lot of publicity, will be sponsoring safety programs in the future.

ACSA trails riding group, national forest service and others were hosted by Wisconsin, thanks to the local directors for attending, showing the destruction from storms, closed bridge, the dangerous reroute. Was a great experience for forest service to see firsthand what it takes to reroute, clean up storm damage. Toured club groomer building and equipment. Head of forest service from Washington DC thought groomers cost \$80,000. They learned a lot on that tour.

Thanks to all the clubs and counties for inviting her, thanks for putting in trails, nice that southern counties could be open.

KAOS leadership in Lakewood was a great weekend, they worked on many leadership skills. Thanks to the local clubs for their continued support of this event.

Next Gen Riders - group of 21-35 year olds, want to remain involved. They are a committee, there will be directors and reps on the committee as oversight. They aren't asking for money, they are working on their own bylaws and mission statement - they want to help. They have divided Wisconsin into six segments, willing to help clubs with events, brushing, signing, whatever you need, if they are available. There will be an article in the September magazine explaining their plans.

Thanks to Greg Roscizewski for stepping up this year. Thanks to Lauren for the years as treasurer, she has brought us into using Square credit card reader, zoom meetings, made forms available electronically, many improvements to the executive board. Thanks to Senator Callahan for help, and the Governor for signing it, mostly for Sam Landes for all he does as legislative chair. Lastly, KAOS, Next Gen Riders, both great organizations.

Lauren Levey- Treasurer - keep your financial information/updates off social media. If you are meeting in a public place, keep your information confidential, not laying around when you leave, not overheard by others. Pick up and turn in your \$100 raffle tickets. KAOS silent auction happening tonight - cash, check, credit cards accepted.

Thank you to all the club members that have supported her during her tenure as the youngest treasurer of the AWSC, brought new ideas and perspective to the board.

Sue Smedegard – Secretary – when posting fundraisers and events on posters or social media, include who, what, when, where and why – don't assume everyone knows what city and state you're in. Don't post activities that violate raffle rules, i.e., bingo if you don't have a bingo license, paddle wheels.

Work with your local chambers and tourism entities, along with law enforcement and DNR.

Annual Meeting Minutes from March 23, 2024—Continued

Sam Landes – Legislative Committee Update - working on a couple bills that got passed and signed - signs on public properties. Act 110 (SB136) - multiplier on supplemental, Lori and Sam attended the Governor signing of that bill.

Brought up - didn't pass - SB816/AB863 - allow public entities to condemn property to acquire it for recreational trails.

SB959/AB1038 - expands the definition of authorized emergency vehicle to include ATV/UTV/ Snowmobiles operated by authorities for emergency use.

SB999/AB1093 - landowners with MFL(managed forest lands) lands must permit use of certain vehicles on existing trails and roads.

Blue Mounds State Park - 3 lawsuits, filed against DNR, not us. Two affect the trail in the park.

Stower Seven Lakes - originally filed against Polk County, challenges the final Mater plan that included snowmobiling and equestrian use. That suit is fully briefed, hoping to see a decision before next season.

Paving trails - most recent is Military Ridge, Omaha and Fox River Trail. We have asked the DNR for specific criteria and how they make the determination to pave.

Back to Act 110/SB136 - multiplier bill. Found legislators don't understand the program, will discuss more in-depth with directors. Shows importance of developing a relationship with your legislators.

Redistricting - keep in mind that many senate and assembly districts will change. New District information is listed on the Wisconsin State Legislature Home Page at [HTTPS://legis.Wisconsin.gov](https://legis.wisconsin.gov) This information is also on the AWSC Home page, click on AWSC PowerPoints tab, then the AWSC Legislative Send Outs tab

Great job by southern counties getting some trails open and maintained. Learned a lot watching the northern counties.

Membership Committee Report - Jim Marks - primary members 37, 223, commercial members 1,492, Total AWSC memberships 38,715. Two programs in place, will have a drawing for those that increase 10% over the last year, or anyone that increased CAM's by 10%

Club with increased membership - Reedsburg Snowmobilers

Club with increased CAM's - Rothschild Urban Aires

International Snowmobile Congress 2024 Report – Lori Heideman, Sue Smedegard, Co-Chairs- working on sponsors, vendors, workshops, round tables, events. Registration goes up April 1 for ISC, hotel is 65% booked, 58 days left in the block. Speakers are confirmed, Wednesday shuttles to Lambeau. Discounted tours are available, you can sign up online. also have a bus going to ISHOF on Tuesday in Eagle River. Registration forms are available from Dave Newman and they're available online.

Old Business – None

New Business - discussion about Dave Newman’s article about how funding works, would like some clarification about how money comes into the program and expenditures. One club learned a hard lesson, bought used groomer, if you do this, negotiate an extended warranty.

Racine County Director comments hospitality rooms getting shut down, choose better place. Will discuss at directors meeting.

Green County club treasurer - issues with SNARS, GTS won’t recognize trails from last year, trail moved 60 feet over. SRC members will look into this. Another issue (different area) is half funding for going around swamps. Lost the funding this year, they weren’t informed in advance by their county trail coordinator.

SECRETARY—Sue Smedegard, Incumbent



Early in 2017, the AWSC Executive Board created an ad hoc Committee to explore the feasibility of creating a Statewide Recognition Program to recognize and reward the volunteer efforts of its 600+ Clubs and the Communities they reside in. Although small, a "Snowmobile Friendly Community Committee" was organized and began to research and review a wide variety of recognition programs in order to create a statewide "Snowmobile Friendly" program to meet the goals laid out by the Executive Board.

By 2018, the SFC Committee finalized their program, and the AWSC formally introduced a new "Snowmobile Friendly Community Program" to the Directors, Reps, and Clubs at Fall Workshop.

There are three main components of the AWSC's Snowmobile Friendly Community Program:

1. Create a Recognition Award: to recognize/thank the dozens of volunteers in the Club and Community who work tirelessly to support, preserve, and protect snowmobiling...(in short, no matter how large or small the community, award them with a sign/symbol celebrating the collective efforts of their local Trails).
2. Create a Tool: to advocate for the preservation and protection of snowmobiling. The Community, Club, or County can use the SFC Award to:
 - Recognize and increase visibility of their Volunteers, (celebrate and motivate)
 - Improve relationships within their community by/thru:
 - Engaging with key stakeholders (educate)
 - Partnerships, activities, and events (participate)
3. Create a Checklist for Success: The SFC Application is also a Standardized Guide for Clubs, Communities, and County organizations. When used as a Checklist, the SFC Program can help Clubs measure and guide their success in four key areas:
Encouragement / Engineering / Education / Enforcement

Today, 11 clubs form the Vilas County Snowmobile Alliance (Cross Country Cruisers, Boulder Junction Snowmobile Club, Sno-Buddies, Sno-Eagles, Northern Hornshoe, Frosty Club, Sno-Skeeters, Phelps Snowmobile Club, Sno-Bunnies, Barnstormers and Bo-Boen.)

Behind every mile of trail, community event, and winter adventure, our dedicated volunteers ensure snowmobiling remains a central part of our culture. These clubs maintain 496 miles of state-funded trails along with numerous club-funded trails.
